1. How to rent a SARAH ISABEL MODA ESPAÑOLA dress/suit

Visit our website www.sidbusinessportal/sarahisabelmoda.com to find all the dresses and suits available for rent.

The rental price includes a period of 4 days for girl's dresses and 7 days for boy's suits.

Dry cleaning service is included in the rental fee for girl's dresses but not for boy's suits.

If temporary and small alterations are needed, it has an extra fee.

Payment is due upon reservation. No cancelation is allowed once paid.

2. Damages, repairs, and stains

The customer is responsible for any damage to the dress or suits.

In the case of the dress or suit being damaged, the customer is not authorized to make any type of alteration, cleaning or repair to this damage.

Cleaning services, included in the rent, do not cover major stains.

These type of damages will be repaired by the specialized service of SARAH ISABEL MODA ESPAÑOLA and will be deducted from the deposit.

The communion suits for boys require a professional cleaning service. The client is responsible for this service before dropping off the suit.

SARAH ISABEL MODA ESPAÑOLA does not allow its clients to sublet the dress/suits or be worn by third parties.

The customer will also be responsible in the event of loss or theft of the rented dress/suits. In these cases and by means of this agreement, the customer authorizes SARAH ISABEL MODA ESPAÑOLA to charge the sale price of the dress/suits, which appears in the product information sheet.



3. Payment and Deposit

Payment can be made by Zelle, credit card or cash. Personal checks are not accepted. Payment is due upon reservation. A security deposit ranging from \$80 to \$350 for girls dresses (depending on the dress) and for boys suits the deposit ranging from \$50 to \$195 (depending on the suit) is required to be paid when the dress or suit will be picked up. The deposit will be returned to the customer when the dress/suit is returned to the us in good conditions. Dresses or suits that are returned with damages, stains or required repairs, SARAH ISABEL MODA ESPAÑOLA will have 7 business days to repair the dress/suits and we will return the remaining of the deposit. If the dress/suit is returned after the 4 day rental for girls / 7 days rental for boys, we will charge \$25 for girls dresses / \$15 for suits per additional day up to a maximum of 4 days. If the dress or suits has not been returned during these extra 4 days, the customer will lose their deposit and SARAH ISABEL MODA ESPANOLA will charge the entire value of the dress to the credit card.
